Where Do I Send the Employee for Medical Treatment?

The Health Center here on campus is the **primary** contact for University employees injured on the job (see <u>University Policy 101.7</u>). Supervisors must ensure employees are sent to an authorized treatment facility.

If an authorized facility is unavailable within a reasonable time period or if you need any assistance, please contact the Workers' Compensation Manager in the Enterprise Risk Management Department at 704-687-0681.

Employees with life threatening work-related injuries should be directed for immediate medical care at Atrium Health - University ER (from a campus phone, dial 911 or from a cell phone, dial 704-687-2200). Employees may <u>not</u> choose their own doctor. Medical treatment sought at an <u>unauthorized</u> facility could result in non-payment of claims.

Prescriptions - Prescriptions can and should be filled at the onsite Student Health Center. If the medication is not in stock or if employee is referred to an off-site authorized treating physician and is prescribed medication, the employee can take the prescription to any major pharmacy such as CVS, Walgreen's, Walmart, etc. to have their first prescription fill (5 days) at no cost. However, they must advise the pharmacist that CCMSI is the third party carrier for the Workers' Compensation program and utilizes Optum Tmesys Network to manage the prescription drug plan.

To obtain the required authorization to fill the prescription, the pharmacist should contact Tmesys at 1-800-964-2531 and give employee DOB, SSN, Rx BIN: *004261* Rx PCN: *CAL*, and Group: *COCMSNCFF*. If the network is not able to obtain authorization or if it is after normal business hours, the employee may pay for the prescription and provide the original copy of the receipt to the WC Administrator who can provide assistance in filing a request for reimbursement consideration through CCMSI.

Physical Therapy - Treatment is covered only when authorized by CCMSI, the third party carrier.
